The Applicant et al waives (i) any right to inspect or approve the finished product in which the Applicant’s Information and/or words are used and (ii) any claim or right the Applicant et al may have in any associated copyright or any other intellectual property, and further understands that the Organization retains all rights, title and interests (including but not limited to any royalties, proceeds or other benefits) in all physical, electronic or digital media which may contain the Applicant’s Information, including (but not limited to) pictures, videos, recordings, audiotapes, streaming, live and archived games, interviews, and events broadcasted through the Internet or otherwise. The Organization is under no obligation to exercise the rights herein granted. The Applicant understands and agrees that he/she will not receive any payment for the possible commercial use of his/her name, image, voice, likeness, or words. PARTICIPANT RELEASE: The applicant and/or participant for themselves and/or any personal representatives, heirs and next of kin (hereafter, “the Applicant et al”) releases, forever discharges, and covenants not to sue SoulPhamm Inc. (and its sponsorship or affiliated programs SoulDeevas, SoulGentz, Nu Sigma Theta), and if applicable owners and lessors of premises upon which the activity takes place, (the foregoing collectively, hereinafter for convenience referred to as the “Organization” or “Releasees”), together with the respective administrators, members (including all categories), volunteers, participants, sponsors and advertisers, together with the insureds, and the Organization’s parents, affiliates, subsidiary companies, and affiliated committees, as well as the officers, directors, agents, attorneys, employees, representatives, successors and assigns of each of the Releasees, and any other party indemnified and held harmless by SoulPhamm Inc.
